

## '2021 YOUTH ART CONTEST' COMPETITION:

### OFFICIAL TERMS AND CONDITIONS

#### ELIGIBILITY

"Youth Art Contest" Competition (hereafter Contest") hosted by the North Alabama Zoological Society an Alabama non-profit organization (hereafter NALZS), 4100 Market Street SW, Huntsville, Alabama 35811, is open to artists who are in grade school and high school as of May 29, 2021. A parent or legal guardian of any Entrant younger than 18 years of age must sign the parental consent signature. All entries, which are prohibited by applicable law, shall be deemed to be void. NALZS reserves the right to verify all eligibility requirements. Contest is subject to all applicable federal, state, and local laws and regulations.

#### HOW TO ENTER

Visit [www.NALZS.org/2021-art-contest](http://www.NALZS.org/2021-art-contest) to complete and submit the online entry form. Follow the directions provided to upload your artwork. Entries are complete when Entrant's artwork has been successfully uploaded.

All entries are FREE. All entries must be received by 11:59 p.m. on the last Friday of the month for each month's contest (the "Standard Deadline"). Each entry must be the original work of the Entrant, and Entrant must be the sole owner of the copyright of such entry. NALZS reserves the right, in its sole discretion, to disqualify any entry it deems to be offensive, inappropriate, derogatory, indecent, obscene, hateful, tortuous, defamatory, slanderous, or libelous, that is not in keeping with NALZS's image or that is otherwise not in compliance with the terms of these Official Contest Rules. In addition, all entries must not contain material that promotes bigotry, racism, hatred, or harm against any group or individual or promote discrimination based on race, gender, religion, nationality, disability, sexual orientation or age, which determination NALZS may make in its sole discretion.

Entrant must have obtained express written consent to submit any entry that contains or features persons other than Entrant, or third-party elements not owned by entrant and, if requested to do so, Entrant must produce such written consent from appropriate parties in a form and manner acceptable to NALZS. All entries must not contain material that violates or infringe another's rights, including, but not limited to, privacy, publicity, or intellectual property rights, or that constitutes copyright infringement.

Personal Submissions by methods other than those stipulated in these Terms & Conditions will not be accepted (no physical submission to NALZS via hand delivery or mail). If such items are mailed or dropped off, they will not count as valid entries and will be considered abandoned property.

## JUDGING

From all entries, NALZS will select art monthly in all grade levels, and a grand prize for each level. Other art may be selected to be featured on our NALZS Education website or Facebook page.

## WINNER NOTIFICATION

Any and all finalists will be notified via email on or before the 1st Monday of the month, and Grand Prize winner will be notified on April 1, 2021. In order to participate for the grand prize, the finalists will be required to mail their artwork to NALZS- % 2021 Art Contest P.O. Box 127, Ryland, AL 35767. Art must not be folded, altered, and damaged in any way. Art will not be returned. As a condition of receiving any prizes awarded by NALZS, all finalists agree to have their works shown in public, failure of which NALZS may award such prizes to an applicable runner-up.

## CONTEST AWARDS

All prize details are at the sole discretion of NALZS. No substitutions or transfers of prizes are permitted by winners. NALZS reserves the right to substitute a prize (or portion thereof) of comparable or greater value, in its sole discretion. Prizes are awarded "as is" with no warranty or guarantee, either express or implied by NALZS.

## USE OF ENTRY

By submitting an entry, Entrant grants NALZS and its designees the irrevocable right and permission or consent, royalty-free, non-exclusive, worldwide perpetual license to use the entry and his/her name, city and state of residence for use on NALZS's website without further compensation, notification or permission, unless prohibited by law. In addition, each winner grants to NALZS and its designees an irrevocable, royalty-free, non-exclusive, worldwide perpetual license to use and distribute the entry (as submitted, or as cropped by NALZS), and his/her name, city, and state of residence in any and all media now or hereafter known for purposes of promotion of the Contest and other NALZS contests and/or for purposes of advertising and promoting NALZS and, except as otherwise stated herein, without further compensation, notification or permission, unless prohibited by law.

The Entrant hereby grants the North Alabama Zoological Society the right and permission or consent to interview, photograph, videotape, and record him/her while he/she is at NALZS. The entrant understands the resulting material may be used by NALZS and/or researchers for educational or scholarly purposes that NALZS may determine, including, but not limited to, publications, exhibitions, and Internet.

The Entrant waives any right to inspect or approve any photo, video, film, written copy, or audio tape taken by NALZS or the person or entity designated by it.

The Entrant further grants the North Alabama Zoological Society a perpetual non-exclusive worldwide license to reproduce, and display copies of oral interviews, conversations and lectures (including without limitation by film, electronic media, videotape, or television), and to authorize others to do the same.

This non-exclusive license, which does not transfer ownership of the Entrant's copyright to the North Alabama Zoological Society, shall survive all assignments of copyright.

The Entrant has read the consent and release, understands it, and intends it to be a binding instrument.

#### USE OF PERSONAL INFORMATION

The personal information of entrants collected in connection with the Contest will be used in accordance with the Privacy Policy Statement below, including, without limitation, for marketing and promotional purposes. This use of entry allows rights only in connection with the execution and promotion of NALZS.

#### MISCELLANEOUS

Released Parties (as defined below) are not responsible for late, lost, garbled, damaged, incomplete, delayed, undelivered, or misdirected entries, or for computer, technical, printing, typographical, human or other errors relating to or in connection with the Contest, including, without limitation, inability to access any website associated with the Contest, errors which may occur in the administration of the Contest, the processing or judging of entries, the announcement of the prizes or in any Contest-related materials. If for any reason, the Contest (or any portion thereof) is not capable of running as planned, including infection by tampering, unauthorized intervention, fraud, technical failures, or any other causes which corrupt or affect the administration, security, fairness, integrity or proper conduct of the Contest, NALZS reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Contest and if terminated, as its discretion, determine winners from among all non-suspect, eligible entries received up to time of such action using judging procedure described above. ### SUBMISSION GUIDELINES

1. Please read the Terms and Contest Rules before submitting your artworks.
2. Fill out the registration form with your name, Grade, school (if applicable), address, phone number & email.
3. Please submit no more than two images of your artwork.
4. Submit title for each image.
5. Image must satisfy all following requirements in order to be considered for entry
  - Must be 72 dpi or higher. No more than 300 dpi.
  - Must be at least 750 pixels in height and width.
  - File size limited to 15MB per image. Keep under 8MB per image for smooth uploading.
  - File must be labeled first name of artist an underscore and with Title of artwork:  
(i.e. taylor\_manateecoast.jpg or taylor\_manateecoast.png)
6. Artwork must satisfy all following requirements in order to be considered for entry
  - Must not exceed 16" h x 20" w
